## RACE 2 – 5:45PM MAGIC MILLIONS NATIONAL YEARLING SALE MAIDEN (1400M)

Good 4 for racing at Cranbourne tonight with the rail a long way out in the 9m position. Setting up for on pacers to be favoured.

#3 MOMETZ comes up short here off a nice return to the races last time. They went slow in the small field, and he made a long, sustained run to eyeball the leader on the turn and condition just gave out late in running 2<sup>nd</sup>. Fitter for that and the step to 1400m suits. We do have some concerns about the map from gate 9, and he was slowly away first up, so the \$1.90 looks too short.

#4 STYLISH PRINCE was good fresh over 1600m when 2<sup>nd</sup> with a gap to 3<sup>rd</sup> after leading. Went back to the trials after that and went nicely before disappointing as favourite 2<sup>nd</sup> up. Think the step back to 1400 is okay and draws to find the lead again from gate 3 with the claim for Logan Bates.

#5 ZAMPARINI SPIRIT trialled very nicely at Balnarring on 30/4 when running on under no riding to finish 2<sup>nd</sup>. He went to Geelong 1<sup>st</sup> up and was luckless in the straight, finishing 5<sup>th</sup> beaten 2L. We have no doubt that with more luck upon straightening he ends up right in the thick of the finish there. Should get a nice run just behind the speed and looks a top winning hope.

#8 GRAVITATION returns to the races for the first run of her 2<sup>nd</sup> prep. Liked the first trial this time in where she led and wasn't asked for an effort. Impressed again at her next trial where she was asked to extend and chased down the leader to win nicely with a space to the rest. The 1400 looks an ideal starting point for the preparation and she has shown good speed in her trials which should mean she is on speed here. Gets in with 55.5kg after the claim for Cartwright.

## RACE 8 – 8:45PM BRIDGESTONE SELECT CRANBOURNE CLASS 1 (1300M)

Will have a good indication of how the track is playing by this stage of the night.

We love the way #6 PRINCESS TORO has been trialling leading into this. Stepped out on 5/5 at Donald over the 850m liked the way she travelled and closed late under no riding. She went to the synthetic for her next trial on 15/5 over 1100m and we liked her work again. She forced her way through a gap at the 200 and was asked to go and she ran through the line very well. The horse she crossed the line with won by 6L yesterday, albeit in maiden grade. Her form at the back end of last prep was sound enough and she looks to have come on over the break.

#1 SANTA ANA MOON won its maiden well at Sandown Lakeside fresh before a good run in a much stronger race during the Warrnambool carnival. He's the favourite here and rightfully so and is the clear main danger.

#3 BUTTERNUT PRINCESS had every chance first up at this track over 1200 and we think she was entitled to do a bit more. She was left flat footed when they sprinted so the step to 1300 is in her favour. She ran well 2<sup>nd</sup> up last preparation and the form around her at the end of last prep is strong.

#7 MY ZEPHYR drops way down in grade for this. Since her maiden win at Donald, she has been thrown in the deep and has run some good races, including being beaten 3L in the Inglis Sprint and 4L in 3YO open company last time. She will find this significantly easier and looks a leading hope.
